- Key Overweight sector/Industries includes Automobile and Auto Components, FMCG and Power vs the Schemes' Benchmark.
- Key Underweights sectors /Industries includes Consumer Services, IT and Healthcare vs the Schemes' Benchmark.
- Carrying Higher cash levels around 12.2% in the portfolio as tight monetary policy in India may continue a bit longer than expected, following higher global policy rates and upside risks to domestic inflation.


