- The Annualised Portfolio YTM of the portfolio is around 7.66%
- The Modified duration of the portfolio is around 2.81 years and would target being in quartile one till the time anecdotal data suggests a weak growth outlook.
- Our portfolio continues to have a large allocation towards gilts, accounting for around 50% of the duration as we are wary of the spreads increasing in AAA credits.

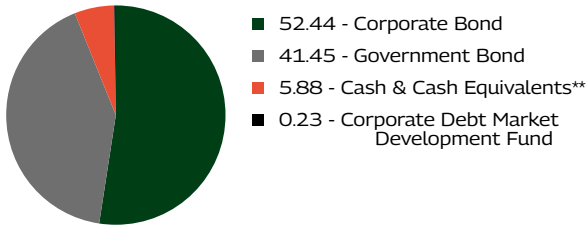

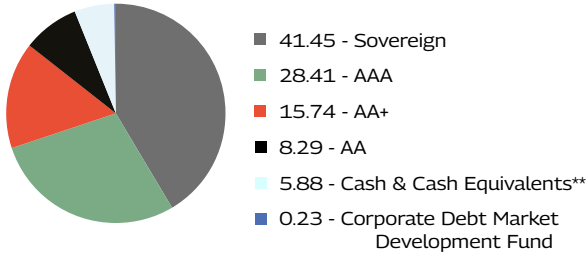
