


## Portfolio Update for the Month

- Key Overweight sector/Industries includes Capital Goods, Banks and Information Technology vs the Schemes' Benchmark. Reduced Overweight in insurance post Union Budget announcements
- Key Underweights sectors /Industries includes Finance, Fast Moving Consumer Goods and Oil & Gas vs the Scheme's Benchmark. Selectively added weight to Oil & Gas based on bottom up ideation
- Portfolio has majority allocation towards large caps with very marginal exposure to mid and small caps currently. However, we continue to evaluate bottom up opportunities in the space


